- If you are a current home owner and have never rented before, proof of ownership must be provided i.e. a copy of your rates notice.
- If you are in the Defence, copy of your Defence I.D.

You will be asked to sign a lease within 24 hours, or at another time agreed by both parties.

At the time of the sign up you must also present your bond. Before receiving the keys for the property, 2 weeks rent must be paid. If you are paying upon signing the tenancy agreement it must be in the form of cheque, money order or cash. If you are paying by bank transfer we require cleared funds by the move in date.
